Authors are requested to be in the vicinity of their paper poster during breaks to discuss and answer any questions. Congress abstracts will be available on the congress mobile App during the congress and published in the INS's journal, *Neuromodulation: Technology at the Neural Interface*, later this year. Support from pharmaceutical partners helps make this event possible. As such, it is important that we comply with the various codes and directives relating to the manufacturing, distribution, and marketing of pharmaceutical products. The Human Medicine Regulations 2012, (clauses 294-300) and the European Union directive (2001/83/EC, article 86) provide guidelines relating to medicinal products for human use. Within these guidelines is the restriction that access to pharmaceutical product marketing activities must be limited to only those participants licensed / authorized to prescribe or supply medicinal products.

All participants, with the exception of the exhibitors, are asked the following question during registration: Are you licensed / authorized to prescribe or supply prescription only medicines? All event activities (including educational sessions, meal functions, exhibit hall, etc.) are exclusively reserved for registered attendees. Non-registered guests (including children, family members, colleagues, etc.) are not allowed in any of the event areas.
